Now these present witnesses and it is hereby mutually agreed as follows:

- 1. In consideration of the payment of the said financial assistance in full or part thereof the student shall successfully complete the research programme under the University. Subject to the Regulations prescribed by the University within a period of five years from the date of receipt of the first instalment of the grant amount and in conformity with the norms approved by the syndicate of the University as amended from time to time.
- 2. In the event of the student not conforming to the said norms and instructions or adverse reports regarding the progress of his research or of his conduct or of his discontinuing his research programme before the expiry of the full period of research the student and the sureties shall on demand pay to the University the amount of financial assistance paid on behalf of the student.
- 3. It is hereby further expressly agreed that all sums found due to the University under or by virtue of this agreement shall be recoverable jointly and severally from the student and the sureties and their properties movable and immovable in such manner as the University may deem fit.
