CIRCULAR

Sub:- Institution Based Portal of UGC - Award of various fellowship schemes of UGC - submitting monthly confirmation form reg.

The University is marking monthly payment confirmation on the basis of continuation certificate, HRA certificate and form for submitting accounts of contingent grant for the release of fellowship, HRA and contingent grant respectively for various fellowship schemes sponsored by the UGC in their institution based portal. As per UGC guidelines these documents have to be submitted by the candidates on quarterly basis. The quarterly period as of now is fixed as 1st January to 31st March, 1st April to 30th June, 1st July to 30th September, 1st October to 31st December, on the basis of the documents submitted by the candidates and after getting approval by the Registrar, the University marks monthly payment confirmation. Now, the UGC vide Public notice dated 5th December 2020 has informed that payments were generated for all eligible research scholars upto November 2020 whose monthly payment confirmation was received on the portal during the months of January, February and March 2020.ie., before the lock down period. Besides the payment is also released for those beneficiaries who are able to mark their monthly confirmation on the Portal.

For the timely disbursal of fellowships to the awardees, the awardees were directed to submit the application for attestation of documents like continuation certificate, HRA certificate and contingent grant certificate immediately after the completion of every quarter. Monthly confirmation of continuation of fellowship shall be submitted on a monthly basis now and the awardees are directed to submit monthly confirmation form (Appended) to the Registrar on or before 5th of every

month. This form can be submitted only by those who have submitted continuation certificate and HRA certificate of the last preceding quarter. The awardees are directed to submit the monthly confirmation form for the month of January 2021 and February 2021 on or before 05/03/2021. Forms submitted after the due date i.e. after 5th of every month will be summarily rejected.

All eligible awardees are also directed to submit the continuation certificate and other certificates of a particular quarter for attestation by the Registrar on or before 15th of subsequent month itself to avoid delay in availing fellowships.

This shall be brought to the notice of all concerned.
