ORDER

As per the U.O read (1) above Registration for Part-time Ph.D Programme was restricted to regular teachers working in the teaching departments/Centres of the University and Government/Aided Colleges within the jurisdiction of the University in line with the UGC norms.

The Syndicate at its meeting held on 10.05.2018, vide paper read as (2) above, considered the recommendation of the Standing Committee of the Syndicate on Academics and Research and resolved to grant Part-time Ph.D Registration to various categories. The matter was placed in the Academic Council held on 05.10.2018, vide paper read as (3) above, and resolved that the combined meeting of the Standing Committee of the Syndicate on Academic and Research and of the Standing Committee of the Academic Council be convened to re-examine the eligibility conditions/eligible categories for Part-time Research leading to Ph. D.

As per the resolution of the Academic Council a combined meeting was convened on 14.11.2018, vide paper read as (4) above and the Syndicate at its meeting held on 16.11.2018 vide item read as (5) above, resolved to approve the recommendation made at the combined meeting. Further the Vice-Chancellor had ordered to convene a combined meeting of the Standing Committee of the Syndicate on Academic and Research and the Standing Committee of the Academic Council on 18.01.2019 and the committee re-examined the eligibility conditions/eligible categories for Part-time Research in detail and made specific recommendations, vide paper read as (6) above. The Syndicate at its meeting held on 22.01.2019, vide paper read as (7) above, resolved to approve the recommendation of the above combined meeting.

The Academic Council held on 13.03.2019 also considered the recommendations of the combined meeting held on 18.01.2019 alongwith the resolution of the Syndicate in the matter and resolved to grant Part-time Ph.D Registration to the following categories who have qualified UGC-JRF/NET/Kerala University Ph.D Entrance/any equivalent examination/ exempted categories:

- a) Teachers working on regular basis in Govt/Govt-Aided Schools in HSE/VHSE/HSA withIn the State.
- b) Lecturers on regular basis in DIET, Teachers in TTI/SCERT/SIEMAT within the State.
- c) Teachers working on regular basis in teaching Departments/Centres of this University.
- d) Teachers working on regular basis in Govt/Aided Colleges including those under DTE/ DME within the State.
- e) Teachers working on contract basis in Teaching Departments of this University.
- f) Faculty Members working on regular basis in the Quasi-State Govt. institutions within the State.
- g) Lecturers working on contract basis in KUCTE, UIT, UIM and Self financing colleges affiliated to the University provided they have service of 5 academic years.
- h) Permanent employees of this University.
- i) Scientists working on regular basis in State/ Central Govt research organisations within the State, with a continous service of 5 years.
- j) Executives working on regular basis in State/Central Govt PSU within the State with a continous service of 5 years.

Further resolved that in each session Part-time Registration to the above categories except (c) & (d) above shall be limited to 25% of the available vacancies in each subjects.

Sanction has therefore been accorded by the Vice-Chancellor to implement the above resolution of the Academic Council.

U.O read as (9) above issued in this regard, which was kept in abeyance stands cancelled. Orders are issued accordingly.
