- 1. To permit the Dean of the faculty concerned, HoD/Chairman, Doctoral Committee and the Research supervisor to participate in the Pre-submission seminar/Open defence through online mode, if necessary
- 2. The request of the research scholar to appear for the Pre-submission seminar/ Open defence through online mode will be considered case by case and the Vice- Chancellor be entrusted to take appropriate decision on genuine ground.
- 3. The presentation of the research scholars in Open defence/ Pre-submission seminar through online mode after the issuance of the U.O read as (1) above, be ratified considering the restrictions imposed in the conveyance protocol due to the outbreak of COVID 19.

Sanction has been accorded by the Vice-Chancellor to implement the above resolution of the Syndicate subject to the directions issued by the Government/University as a part of COVID 19 epidemic management.

The University order read as paper (1) above stands modified to the above effect.
