ORDER

The Syndicate at its meeting held on 23.09.2021, vide paper read as (2) above, considered the application submitted by the Principal, Christian College, Chengannur, for granting recognition to the Department of Chemistry as an approved Research Centre of the University and resolved to constitute an inspection commission to evaluate the infrastructural and research facilities of the Department.
