The Regulations for the award of University Post Doctoral Fellowship came into force w.e.f 1st June 2016 vide

U.O read as paper (1) above.

The Syndicate at its meeting held on 17.08.2021 resolved to revise the norms for granting University Post Doctoral Fellowship and entrusted a sub-committee comprising of Dr.S Nazeeb, Dr.K.G Gopchandran, Dr.Gabriel Simon Thattil and Dr.K.B Binoj Kumar to prepare a detailed proposal for the revision of Regulations for the Award of University Post Doctoral Fellowship and to place the same before the Standing Committee of the Syndicate on Academics and Research.

The Syndicate at its meeting held on 04.12.2021 vide Item No. 34.122.C9 considered the minutes of the meeting of the above Sub-committee held on 19.11.2021, along with the modifications suggested by the Standing Committee of the Syndicate on Academics and Research vide paper read as (3) above, and resolved to approve the same with

modifications.

Sanction has therefore been accorded by the Vice-Chancellor to implement the revised norms, as approved by the Syndicate, for granting University Post Doctoral Fellowship to the Post Doctoral Fellows in the University Teaching Departments.(Norms appended)

UNIVERSITY OF KERALA REVISED NORMS FOR GRANTING UNIVERSITY POST DOCTORAL FELLOWSHIP

- 1. Both categories of fellowship-Bridge and Regular shall not be entitled to any annual contingent grant.
- 2.The Post Doctoral fellow shall be entitled to avail with the prior permission of both the mentor and HOD 12 medical leave per year. However they shall not be entitled to any special casual leave.
- 3. Registration fee for PDF has been fixed as Rs. 550/-.
- 4. Publications in Impact factor/Scopus/UGC-Care listed journals only to be considered.
- 5.On getting permanent employment the Post Doctoral Fellow who have completed 6 months of post doctoral research shall be permitted to continue their research without fellowship. They shall submit the report within the stipulated period of one year and will not be considered for granting second year extension.
- 7.The Selection committee as per clause 8.1 of the Regulations has been reconstituted. The new selection committee includes the Pro-Vice-Chancellor (Chairman), Research Director (Convenor), One External Expert, One Intenal Expert, Deans of the faculties concerned and IQAC Director. The subject experts (External and Internal) shall be nominated by the Hon'ble Vice-Chancellor. The PVC and the two experts constitute the interview board and the Dean and IQAC Director are the observers. The selection shall be based on a maximum of 40 marks spread over in two components (i) performance in the presentation before the selection committee (maximum of 10 marks) (ii) research papers published /patent application published (maximum of 30 marks @ 5 marks for each paper/patent application).
- 8.The above modifications except 7 is to be followed from 2021-22 session onwards. The modifications suggested as per 7 is to be followed from 2020-21 session itself.
- 9. The external expert in the selection committee can participate in either online or offline mode.
