ORDER

As per University Order read (1) above, revised norms were framed for granting approval as research guides of the University of Kerala.

The Syndicate at its meetings held on 16.02.2012 and 10.10.2013 along with the recommendations of the Standing Committees of the Syndicate on Research and Scholarships held on 25.01.2012 and 01.10.2013 (read as 2 & 5 above), considered the matter of further revision of the existing norms for approval as Research Guides of University of Kerala and resolved to revise the existing norms by incorporating the following condition.

- 1. Teachers of University Departments/Affiliated Colleges should possess a minimum of two years experience in teaching.
- 2. Scientists, Technical Staff, Pool Officers working in the University Departments and approved research Centres should possess a minimum of two years research experience.
- 3. Two or more years of Post Doctoral Experience in reputed Institutions will be reckoned as one year teaching/research experience only for the purpose of granting guideship.
- 4. Teachers/Scientist/Equivalent research staff in service will be eligible for guideship only one year after the award of Ph.D. Degree.
- 5. Guideship will be granted only upto 60 years.

Sanction has therefore been accorded by the Vice-Chancellor to revise the existing norms for granting approval as research guides of the University of Kerala by incorporating the above conditions.

Orders are issued accordingly.
